

**MINUTES OF PROCEEDING OF THE SPECIAL MEETING OF THE CANTONMENT BOARD JUTOGH HELD ON 22.09.2015 AT 1330 HRS. IN THE OFFICE OF THE CANTONMENT BOARD JUTOGH.**

**22. OATH OF ALLEGIANCE**

To take oath of the allegiance by Brig. J. K. S. Virk, SM, President of Cantt. Board Jutogh before taking his seat in the Board.

**22. RESOLUTION**

Brig. J. K. S. Virk, SM, took the oath of allegiance to the Constitution of India as per Section 17 of the Cantonments Act, 2006 before taking his seat as the President of Cantonment Board Jutogh.

**23. TA/DA CLAIMS OF ELECTED MEMBERS OF JUTOGH CANTONMENT FOR ATTENDING ORIENTATION PROGRAMME AT DELHI (16.06.2015 TO 17.06.2015).**

Reference Dte. General Defence Estates Raksha Sampada Bhawan, Ulaanbaatar Delhi Cantt. D.O. No.76/38/Orientation Course/Ems/CBs/C/DE dated 18.05.2015 and this office letter No.CBJ/67/94 dated 08.06.2015.

To consider the applications dated 08.07.2015 received from Vice President Sh. Karunjeet Singh and Smt. Sarika Mittal, Elected member Cantonment Board Jutogh regarding payment of their TA/DA claims for attending the Orientation program at Delhi.

TA/DA claims received from both the members amount to Rs.29800/- each, which is much higher than their entitlement as per applicable guidelines. As per their entitlement, payment of Rs.13184/- to each member has been proposed by the Accountant, Cantt. Board Jutogh, alongwith justification.

All the relevant papers including office report are placed on the table for the consideration of the board.

**RESOLUTION**

23. The Board considered, discussed and approved the payment of Rs.13184/- to each elected member as TA/DA claim for the subject purpose .In addition each elected member be also paid the amount arrived at as per the ordinary rates of DA for food charges, as per rules. Further, after hearing the views of elected members and after detailed discussion, the Board resolved that

in order to determine whether the members can be paid the additional amount, necessary guidelines/ clarification be sought separately from the Dte. DE, WC, Chandigarh to determine as to whether the additional payment can be made to them or not. However, in the mean time, the payment as resolved above, be made to both the members.

**24 ENGAGEMENT OF JUNIOR ENGINEER SH. DAYANAND DHARIK ON CONTRACT BASIS :-**

Reference CBR No. 02 dated 24.04.2015

To consider the application dated 10.09.2015 received from Sh. Dayanand Dhraik S/o Sh. Parma Nand Dhraik, village Khalti, P.O Sarahan Bushahr, Tehsil Rampur Bushahr, Distt Shimla H.P 172102, JE (Civil), engaged on contract basis by the Cantt. Board Jutogh for extension of his engagement for suitable period.

In this connection it is for the appraisal of the Board that Sh. Dayanand Dhraik, JE(Civil) was engaged first time vide this office letter No.CBJ/81-E/221 dated 06.09.2014 and he joined his duty in this office on contract basis on 17.09.2014 for the period of 06 months on honorarium basis of Rs 14500/- per month. His above period of 06 months expired on 16.03.2015. He further applied on 02.03.2015 to extend his contract for suitable period. His application was referred to the Board vide circular agenda item No.1 dated 20.03.2015. The board resolved to engage him on contract basis under the same terms and conditions for a period of 06 months w.e.f 23.03.2015 to 22.09.2015 by executing fresh agreement. Now his period of contract expires on 21.09.2015 and he again applied (vide his application dated 10.09.2014) to extend the contract for suitable period.

It is pertinent to mention here that technical supervision of Junior Engineer (Civil) is required for proper execution of the maintenance works of the Cantt Board. Junior Engineer (Civil) also has to deal with land cases such as, encroachment, unauthorized construction, mutation, renewal of leases etc and presence of JE is required for the same. In the circumstances explained above, the Board may consider further action in the matter.

In this connection all relevant papers are placed on the table.

**RESOLUTION.**

24. The Board considered and discussed the matter in detail. The Board resolved that engagement of Junior Engineer (Civil) be done through outsourcing, once the outsourcing tender is approved by the Board and necessary steps like execution of agreement etc. have been finalized. Further, the Board resolved that for the mean time, the contract of Sh. Dayanand Dhraik S/o Sh. Parma Nand Dhraik, village Khalti, P.O Sarahan Bushahr, Tehsil Rampur Bushahr, Distt Shimla H.P 172102 as Junior Engineer (Civil) purely on contract basis on monthly honorarium of Rs.14500/- and on same terms and conditions of previous contract, be extended for further period of 03 months w.e.f 28.09.2015 to 27.12.2015 under the provision of Section 126 of Cantt. Act, 2006, by which time the process of engagement of Junior Engineer (civil) through outsourcing be completed.

The Board further resolved that fresh agreement be executed with Sh. Dayanand Dhraik for the period of contract and CEO is authorized to incur the expenditure.

Due to the demise of Sh. B.S. Banyal, Sanitary Inspector-cum-Food Inspector, on 15.07.2015, the post of Office superintendent-cum-Accountant, which was being officiated by Late Sh. B.S. Banyal has fallen vacant since 15.07.2015 and is now being officiated by Sh. Sushil Kumar. The post of Office Superintendent-cum-Accountant is a supervisory post and is declared as promotional post under rule 5B (5) of CSFR 1937 by the G.O.I., Min. of Defence (ML&C Dte) letter No.25/83/C/73 dated 04.12.1976 (amended) to be filled up from amongst the clerks. Tender was opened in the office of Cantonment Board Jutogh by tender opening committee in the presence of interested contractors and elected members.

Out of above three tenderers/bidders, 02 Bids were found technically correct and 01 bid ( V. Eagle Security Services, Room No. 12, Third Floor, Modern Apartment Fingask Estate Near Kail Bari, the Mall Shimla) was rejected in technical evaluation process for want of required documents (did not score qualifying marks as per evaluation matrix, qualifying marks were 35/70).

M.S. Services Private Limited is a Micro and Small Enterprise (MSE) registered with National Small Industries Corporation Limited (NSIC), and as per guidelines issued by Govt. of India, Min. of Micro Small and Medium Enterprises, Udyog Bhawan, New Delhi letter No. 9(14)/2007-SSI(P)-I dated 08-03-2015, they claimed relaxation in payment of fee for earnest money deposit.

The technical bids of M.S. Services Private Limited and New Eagle Services were accepted.

Services of a legal advisor are required for Cantonment board to defend the various court cases of Cantt. Board Jutogh and to seek/obtain legal advice in various matters from time to time.

32. **RESOLUTION.**

Considered. After detailed discussion, the board approved the appointment of Sh. Surinder Steta as Standing Council of Cantt. Board Jutogh for a period of 03 years on retainer fees Rs.4000/- per month (as fixed by the Govt. of India Ministry of Law & Justice Department of Legal Affairs Judicial Section No.27(25)/2011-Judl dated 01<sup>st</sup> September, 2011 or amended/revised from time to time by the Law Ministry will be applicable) Board further resolved that the necessary agreement may be executed with the advocate Sh. Surinder Steta and CEO is authorized for further necessary actions and to incur expenditure in the matter.

33. **INTER SCHOOL FRIENDLY SPORTS MEET**

Cantt. Board Jutogh is running a co-educational Middle school with a strength of around 97 students. The elected members are keen that an inter-school friendly sports meet be organized by the Cantt. Board . In this regard meetings have been held between the SMC ( School management Committee) and the elected members also. The SMC has also submitted a proposal for the same vide letter No. Nil dated 24.08.2015. Cantt. Board office has also held meetings with elected members, headmaster etc. In these meetings & discussions, the following have been agreed to, in principle.

1. Successful conduct of the sports meet will be possible subject to necessary support & assistance by St. HQs Jutogh. e.g., Provision of ground etc. for the sports meet
2. Understanding the existing infrastructure and logistic realities, it is agreed that the sports meet will be a day event only. The meet will be held for a maximum of three (03) days , including opening and closing ceremony etc. Further, no events will be held after Sunset. Cantt. Board Jutogh will not be liable to make any travel/stay arrangements for any of the students/ guardian/ guests etc. If required, Stay Arrangements for referees will be done in Old Dispensary.
3. Only for the purpose of this sports meet , the Board can issue an advance payment of Rs.75,000/- to the Headmaster, Cantt. Board Middle School Jutogh, which can be recouped as per rules applicable. This is only to facilitate timely preparations for the sports meet. The Purchases /expenses shall be made strictly in accordance with applicable rules. Further, Budget provisions be adhered to.
4. For the purpose of effective organization and holding of the sports meet, an organizing committee be formed with SMC, RMO, Vice President, two teachers as members.
5. As it is being organized for the first time, the eligibility for participation and attendance for schools other than Cantt. Board Middle School Jutogh, age limit shall be limited 14yrs to 17yrs and maximum participation will be 25 per school or 100 total, whichever is less.

**33. RESOLUTION:**

Considered, discussed and approved that inter school friendly sports meet be organized by Cantt. Board Jutogh on the broad outlines as given above, subject to the conditions that i) Decision on point 03 is deferred. ii) the organizing committee shall submit a detailed programme for the same. The programme should clearly bring out the names of participating schools, number of students participating, eligibility criteria, schedule of events, budget, areas assigned to different members of organizing committee etc. The programme should be submitted for consideration of the Board.
